AN ORDINANCE AMENDING THE METHOD OF COMPENSATION
OF ELECTED OFFICIALS IN THE VILLAGE OF BIG ROCK

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, 65 ILCS 5/3.1-50-15 provides that an ordinance fixing compensation for members of the corporate authorities shall specify whether those members shall be compensated (a) at an annual rate, or (b) for each meeting of the corporate authorities actually attended if public notice of the meeting was given; and

WHEREAS, the Village of Big Rock has traditionally compensated members of the corporate authorities on the basis of each meeting of the corporate authorities actually attended; and

WHEREAS, the Village of Big Rock corporate authorities now desire amend this method of compensation to provide that members of the corporate authorities shall be compensated at an annual rate; and

WHEREAS, the Village of Big Rock corporate authorities do not intend to amend the *amount* of compensation paid, but instead desire to only amend the *method* of compensation in order to assist with budgeting, accounting and payroll purposes; and

WHEREAS, the Village President currently is compensated at the rate of \$150.00 per meeting attended, and earns \$3,600.00 per year for the 24 regularly-scheduled meetings per year of the corporate authorities; and

WHEREAS, this ordinance proposes to fix the annual compensation of the Village President at \$3,600.00 per year, payable once per month; and

WHEREAS, members of the Village Board of Trustees currently are compensated at the rate of \$100.00 per meeting attended, and earn \$2,400.00 per year for the 24 regularly-scheduled meetings per year of the corporate authorities; and

WHEREAS, this ordinance proposes to fix the annual compensation of the Village Board of Trustees at \$2,400.00 per year, payable once per month.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The method of compensation of the Village President is amended so that the Village President is compensated at an annual rate. The annual rate is set at \$3,600.00,

which amount shall be paid once per month, and which equals the current compensation rate for the Village President.

Section 3: The method of compensation of members of the Village Board of Trustees is amended so that such members are compensated at an annual rate. The annual rate is set at \$2,400.00 for each member, which amount shall be paid once per month, and which equals the current compensation rate for members of the Village Board of Trustees.

Section 4: In the event that any member of the corporate authorities misses three (3) consecutive regularly-scheduled meetings of the corporate authorities during any fiscal year, such member shall not receive his or her next-scheduled monthly installment payment.

Section 5: This amendment to the method of compensation for elected officials shall become effective on February 1, 2018.

Section 6: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 7: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
