AN ORDINANCE APPROVING AN INTERGOVERNMENTAL COOPERATION
CONTRACT WITH THE ILLINOIS MUNICIPAL LEAGUE
RISK MANAGEMENT ASSOCIATION

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Illinois Municipal League Risk Management Association has established and operates a cooperative program of risk management in which the Village of Big Rock participates as a member; and

WHEREAS, the Village of Big Rock, along with other Illinois municipalities, participate in this program to create self-insured reserves against losses and jointly purchase excess insurance, reinsurance and administrative services; and

WHEREAS, the Village of Big Rock desires to approve an Intergovernmental Cooperation Contract with the Illinois Municipal League Risk Management Association to allow the Village to continue to participate in this program for the purpose of obtaining workers' compensation insurance and property/casualty coverage; and

WHEREAS, the Village of Big Rock Board of Trustees find that approval of this Intergovernmental Cooperation Contract will protect and serve the public interest.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The Intergovernmental Cooperation Contract with the Illinois Municipal League Risk Management Association, a copy of which is attached hereto, is hereby approved. The Village President and Village Clerk are authorized and directed to execute this Contract on behalf of the Village and to return a signed original to the Illinois Municipal League Risk Management Association.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
