#### ORDINANCE NO. 2016-\_\_\_\_ AN ORDINANCE APPROVING AN AGREEMENT WITH VAN WAGONER TRUCKING FOR SNOW REMOVAL SERVICES (CONTRACT "B")

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village requires services and equipment to perform snow removal services on a portion of Village roadways during the 2016-17 winter season, as the Village does not have employees and equipment to perform such services; and

WHEREAS, Van Wagoner Trucking ("VWT") has available personnel, equipment and experience to perform snow removal services of Village roadways, and is willing to provide such services to the Village pursuant to an agreement; and

WHEREAS, pursuant to the Agreement, VWT shall provide snow removal services for Village roadways located north of Granart Road, and the total costs for said services shall not exceed \$20,000.00; and

WHEREAS, no competitive bidding is required for this agreement as it is an agreement for non-professional services only, however, the Village has previously negotiated costs with other contractors and the Big Rock Township Road District, and finds that the proposed agreement with VWT represents the best combination of cost and responsiveness to Village needs for the benefit of the residents; and

WHEREAS, the Village of Big Rock President and Board of Trustees desires to approve this Agreement, finding that it will serve the public interest and will promote the health, safety and welfare of Village residents.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

- Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.
- Section 2: The Agreement (Contract "B") between the Village of Big Rock and VWT, a copy of which is attached hereto as Exhibit "A" and incorporated herein, is hereby approved. The Village President and Village Attorney are authorized to make minor revisions to this Agreement after further consultation with VWT. The Village President is authorized and directed to execute this Agreement on behalf of the Village.
- <u>Section 3:</u> All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.
- <u>Section 4</u>: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
