**AN ORDINANCE ACCEPTING THE BID OF BUILDERS PAVING, LLC**  
**AND AUTHORIZING A CONTRACT WITH BUILDERS PAVING, LLC**  
**FOR THE WELTON ESTATES STREET RESTORATION PROJECT**

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village, through its consulting engineer, prepared a bid package and publically advertised for bids for the Welton Estates Street Restoration Project; and

WHEREAS, the Village publicly opened and read the bids which were timely received, and the bid of Builders Paving LLC in the amount of \$70,088.00 was the lowest bid received and was below the engineer's estimate for this project; and

WHEREAS, the Village Board of Trustees desires to accept the bid of Builders Paving, LLC for the afore-mentioned street restoration project, finding this bid to constitute the lowest responsible bid, and finding this bidder to be qualified to perform the work; and

WHEREAS, the Village Board of Trustees further desires to authorize the execution of a contract with Builders Paving, LLC for the street restoration project, finding this work will benefit the public.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The bid of Builders Paving, LLC for the Welton Estates Street Restoration Project in the amount of \$70,088.00 is hereby accepted as the lowest responsible and responsive bid.

Section 3: The Village Attorney and the Village's consulting engineer are directed to prepare a contract between the Village and Builders Paving, LLC for this street restoration project, with said contract to be consistent with the bid documents and the accepted bid. The Village President is authorized and directed to execute said contract once it is finalized by the Village Attorney and consulting engineer, without the need for further Board of Trustees' approval.

Section 4: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 5: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
