**ORDINANCE NO. 2017- 15**  
**AN ORDINANCE APPROVING A POWER SUPPLY AGREEMENT WITH MC  
SQUARED ENERGY SERVICES, LLC FOR VILLAGE-OWNED PROPERTIES  
AND FACILITIES**

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock is the owner of certain properties and facilities, including a wastewater treatment plant located at 3000 West Lincoln, Big Rock, Illinois which provides treatment of wastewater from Village residents and businesses who are connected to the Village's wastewater treatment system; and

WHEREAS, the wastewater treatment plant requires electrical power to operate and it is necessary for the Village to contract with an electrical supplier to supply the electricity for the wastewater treatment plant, and other Village properties and facilities, which will be delivered via Commonwealth Edison's electrical distribution system; and

WHEREAS, the Village of Big Board of Trustees desires to enter into a Power Supply Agreement with MC Squared Energy Services, LLC to provide said electrical power to the wastewater treatment plant and other Village-owned properties and facilities, for a term of 36 months at a fixed price of \$0.06065 per k/hr., finding said electrical pricing to be the most competitive in the marketplace and finding this agreement to be in the public interest.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The Power Supply Agreement between the Village of Big Rock and MC Squared Energy Services, LLC for electrical power for the Village's wastewater treatment plant and other Village-owned properties and facilities, a copy of which is attached hereto as Exhibit "A," is hereby approved. The Village President is authorized and directed to execute this Agreement on behalf of the Village of Big Rock.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.


