AN ORDINANCE APPROVING THE PROPOSAL OF BUILDERS PAVING, LLC
FOR THE CAMP DEAN ROAD RESURFACING PROJECT

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock requires resurfacing (paving) work to a portion of Camp Dean Road and received a proposal from Builders Paving, LLC to perform said paving work for the cost of \$19, 785.00; and

WHEREAS, the Village of Big Rock desires to approve said proposal, finding the work will benefit the public, finding Builders Paving, LLC qualified to perform the work, and finding that it is not necessary to publicly bid this work as the total cost of the work is less than \$20,000.00.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The proposal of Builders Paving, LLC for the Camp Dean Road Resurfacing Project in the amount of \$19,785.00, a copy of which is attached hereto as Exhibit "A," is hereby approved.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
