## AN ORDINANCE APPROVING THE BUDGET FOR THE VILLAGE OF BIG ROCK FOR THE FISCAL YEAR COMMENCING ON MAY 1, 2018 AND ENDING ON APRIL 30, 2019

**WHEREAS**, the Village of Big Rock has adopted the procedures of the Budget Officer Act (65 ILCS 5/8-2-9.1 et seq.); and

**WHEREAS**, the Budget Officer for the Village has proposed a Budget for fiscal year 2018-19 for the Village of Big Rock and has presented said Budget to the Village Board for approval with this Ordinance; and

**WHEREAS**, this Budget Ordinance replaces the annual Appropriation Ordinance for the Village of Big Rock; and

**WHEREAS,** after posting this Budget for public inspection and conducting a public hearing, the Village of Big Rock corporate authorities desire to approve this Budget, finding this Budget to be in the best interest of the Village and will promote the public health, safety and welfare.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Village Board of the Village of Big Rock. Kane County, Illinois, as follows:

**SECTION 1**: The Budget for the Village of Big Rock for the fiscal year commencing on May 1, 2018 and ending on April 30, 2019 is hereby approved. A copy of said Budget shall be placed on file with the Village Clerk.

**SECTION 2**: The Village Clerk shall promptly file a certified copy of said Budget, once finalized, and the corresponding Ordinance with the Kane County Clerk.

**SECTION 3**: All ordinances and parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict.

**SECTION 4**: This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
