- Section 2: The Letter of Engagement dated April 24, 2017 between the Village of Big Rock and Sikich, LLP, a copy of which is attached hereto as Exhibit "A," is hereby approved. The Village President is authorized and directed to execute this Letter of Engagement on behalf of the Village of Big Rock.
- <u>Section 3:</u> All ordinances or resolutions or parts of ordinances or resolutions in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.
- Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
