**AN ORDINANCE APPROVING THE BUDGET FOR THE VILLAGE
OF BIG ROCK FOR THE FISCAL YEAR COMMENCING ON
MAY 1, 2017 AND ENDING ON APRIL 30, 2018**

WHEREAS, the Village of Big Rock has adopted the procedures of the Budget Officer Act (65 ILCS 5/8-2-9.1 et seq.); and

WHEREAS, the Village of Big Rock corporate authorities adopted a Preliminary Budget for fiscal year 2017-18 on April 25, 2107; and

WHEREAS, the Budget Officer for the Village has proposed a Budget for fiscal year 2017-18 for the Village of Big Rock and has presented said Budget to the Village Board for approval with this Ordinance; and

WHEREAS, this Budget Ordinance replaces the annual Appropriation Ordinance for the Village of Big Rock, and this Budget replaces the Preliminary Budget adopted on April 25, 2017; and

WHEREAS, after posting this Budget for public inspection, advertising for a public hearing as required by law and conducting a public hearing, the Village of Big Rock corporate authorities desire to approve this Budget, finding this Budget to be in the best interest of the Village and will promote the public health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED by the President and Village Board of the Village of Big Rock. Kane County, Illinois, as follows:

SECTION 1: The Budget for the Village of Big Rock for the fiscal year commencing on May 1, 2017 and ending on April 30, 2018 is hereby approved in form and substance as set forth in Exhibit “A” attached hereto and made a part hereof.

SECTION 2: The Village Clerk shall promptly file a certified copy of said Budget and the corresponding Ordinance with the Kane County Clerk.

SECTION 3: All ordinances and parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict.

SECTION 4: This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
