WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock desires to obtain the services of Sikich, LLP, certified public accountants and advisors, to perform an accounting compilation and other related year-end accounting services for the Village of Big Rock; and

WHEREAS, the Village of Big Rock has utilized Sikich, LLP in past years for these services, finds Sikich, LLP to be qualified to perform municipal-related accounting services, and finds the fees for their services to be reasonable.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The Agreement for Audit Services dated January 4, 2018 between the Village of Big Rock and Sikich, LLP, a copy of which is attached hereto as Exhibit "A," is hereby approved. The Village President is authorized and directed to execute this Agreement on behalf of the Village of Big Rock.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
