**AN ORDINANCE APPROVING AN AGREEMENT FOR TECHNICAL SERVICES WITH STRAND ASSOCIATES, INC.**

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village requires the services of a professional civil engineer from time to time for various public works projects and for consultation on various non-public works projects; and

WHEREAS, Strand Associates, Inc. has offered to provide professional civil engineering services to the Village on an as-needed basis for various projects pursuant to the terms of its Agreement for Technical Services (“Agreement”); and

WHEREAS, the Village of Big Rock Board of Trustees desires to approve this Agreement and to utilize Strand Associates, Inc. for its various civil engineering needs from time to time, finding Strand Associates, Inc. to be qualified to perform civil engineering work for the Village and finding the Agreement to be in the public interest.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The Agreement with Strand Associates, Inc., a copy of which is attached hereto as Exhibit “A,” is hereby approved. The Village President is authorized and directed to execute this Agreement on behalf of the Village.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
