### COMMITTEE OF THE WHOLE CONSIDERATIONS

#### DRAINAGE COMMITTEE REPORT

Wastewater Final Completion/Warranty Issues, Past Due Sewer Invoice Collection(s)

- -The flow rates with the recent rains have been significantly better than previous years. Thus the tele-grouting procedure done last summer to all the septic tanks has proven to be effective in decreasing the amount of ground water being treated in the sanitary sewer system.
- -Dean is still working to extract the large amount of emails on the office computer for the pending lawsuit with H. Linden & Sons.
- -Tim has been successful in speaking with several residents with overdue/past due sewer payments and obtaining proper payments to avoid sewer shut-off.

#### STREET MAINTENANCE REPORT

-The village will need to possibly look to pay for salt storage due to the amount of supply it has on hand. This winter has proven not to need much snow removal and salt spread on the roadways.
