DRAINAGE COMMITTEE REPORT Wastewater Final Completion/Warranty Issues

- -The village discussed continuing to notify residents that it randomly is checking for compliance with any illegal sump pump hookups to the sanitary sewer system. This type of hookup or discharge is strictly prohibited via the village ordinance.
- -There was a north side drainage district meeting recently. Dean proposed that each entity take responsibility for its portion. The village would repair/replace its part (that directly drains the Tenerrelli subdivision) and then the drainage district would need to take care of their part.
