ORDINANCE NO. 2015-____ AN ORDINANCE APPROVING THE VILLAGE OF BIG ROCK LANDSCAPING STANDARDS

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, pursuant to its zoning and police powers, the Village of Big Rock has the authority to establish and require minimum landscaping standards for new development of private property within the Village of Big Rock; and

WHEREAS, the Village of Big Rock previously enacted landscaping standards as part of its Zoning Ordinance, but the Big Rock Board of Trustees determined that it was in the best interests of the Village to remove said landscaping standards from the Zoning Ordinance, and to revise and adopt those landscaping standards as a stand-alone ordinance; and

WHEREAS, the Village of Big Rock Board of Trustees desires to adopt the Village of Big Rock Landscaping Standards attached hereto, which govern and control (a) parkway landscaping, (b) perimeter landscaping, (c) lot landscaping, and (d) parking lot landscaping, and finds that adoption of these Landscaping Standards will serve, promote and protect the public interest.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

- Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.
- Section 2: The Village of Big Rock Landscaping Standards, a copy of which are attached hereto as Exhibit "A," are hereby approved.
- <u>Section 3:</u> All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.
- <u>Section 4</u>: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
