**AN ORDINANCE APPROVING A PROPOSAL FOR LANDSCAPE SERVICES FROM WHEATON LANDSCAPE SPECIALISTS, INC.**

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock desires to retain an independent contractor to perform grass mowing and related services of Village rights-of-way and property; and

WHEREAS, Wheaton Landscape Specialists, Inc. provided a proposal dated May 12, 2015 to perform such services at a cost of \$1,501.00; and

WHEREAS, the Village of Big Rock Board of Trustees desires to approve this proposal and desires to authorize this work, finding that the pricing and scope and quality of services is competitive and will benefit the public.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The proposal for grass mowing and related services from Wheaton Landscape Specialists, Inc., dated May 12, 2015 in the amount of \$1,501.00, a copy of which is attached hereto as Exhibit "A", is hereby approved. Upon completion of these services, the Village President is authorized to approve additional, related services for future grass mowing needs of the Village during Year 2015, subject to approval of invoices for said work by the Village Board.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
