ORDINANCE NO. 2015- 14 AN ORDINANCE APPROVING A PROPOSAL FROM COLT O'DONNEL FOR MADISON AVENUE RIGHT-OF-WAY IMPROVEMENTS (SHOULDER WORK)

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock desires to make improvements to the Madison Avenue right-of-way by placing compacted gravel in the shoulder area adjacent to the Big Rock Park District park; and

WHEREAS, Colt O'Donnell has successfully performed right-of-way improvement work to the Village in the past and has submitted a proposal to perform this work in the amount of \$7,180.00; and

WHEREAS, it is not necessary for the Village to publicly bid out this work as the amount of the work is less than the statutory requirements for publicly-bid public improvement projects; and

WHEREAS, the Village of Big Rock Board of Trustees desires to approve the proposal from Colt O'Donnell and desires to authorize this work, finding that this proposal and these services will serve and promote the public interest.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The proposal from Colt O'Donnell for Madison Avenue right-of-way improvements (shoulder work) in the amount of \$7,180.00, a copy of which is attached hereto as Exhibit "A," is hereby approved. The Village President is authorized to sign-off on said proposal and authorize the work to begin.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
