**AN ORDINANCE AWARDDING THE BID TO GENEVA CONSTRUCTION**  
**FOR THE BNSF QUIET ZONE PROJECT AND AUTHORIZING A**  
**CONSTRUCTION CONTRACT CONSISTENT WITH THE BID DOCUMENTS**

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock desires to make public improvements in and around the BNSF railroad intersection with Rhodes Road known as the BNSF Quiet Zone Project; and

WHEREAS, the Village of Big Rock advertised for bids for this Project in accordance with State statute and received numerous responsive bids; and

WHEREAS, upon the opening and review of those bids by the Village's consulting engineer, the consulting engineer recommended Geneva Construction as having submitted the lowest responsible bid for this Project; and

WHEREAS, the Village of Big Rock Board of Trustees finds that the bid of Geneva Construction constitutes the lowest responsible bid and desires to award the bid to Geneva Construction and to authorize a construction contract consistent with the approved bid documents, finding that this bid and this Project will serve the public interest.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The bid of Geneva Construction for the BNSF Quiet Zone Project is determined to constitute the lowest responsible bid, and said bid is approved and awarded to Geneva Construction. The Village authorizes the consulting engineer to prepare a construction contract for this Project with Geneva Construction consistent with the bid documents, and authorizes the Village President to execute said construction contract on behalf of the Village.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.



In accordance with the Advertisement for Bids, the Village of Big Rock opened bids for the BNSF Grade Crossing Improvements for the Quiet Zone Application Project on Thursday, July 30, 2015.

The project consists of asphalt pavement, concrete sidewalks, guardrail, fencing and signs at the approaches to the BNSF railroad crossing at Rhodes Street in the Village of Big Rock.

Four (4) contractors purchased plans and specifications for the project. Bids were submitted by two (2) contractors. The bids were as follows:

The attached Bid Tabulation gives an itemized cost for all of the bids. The low bidder Geneva Construction Co. of Aurora, IL was \$64,232.60, or 56.9% higher than the Engineer's Estimate of \$112,896.00.

The Big Rock Quiet Zone Project bids received are significantly over the Engineer's Estimate. The estimated unit costs were reflective of a much larger scale project completed in 2012 in West Chicago, Illinois. The explanation for the high unit costs were only two (2) bids were received, small quantities not creating full 8 hour work days, tight area with extensive traffic control/awkward installation, and downtime per BNSF flagger and permit anticipated.

Rempe-Sharpe has coordinated an exhaustive effort to reduce the project cost. Those line items that were agreed by Geneva Construction for Change Order value-engineering price reduction were:

The Engineer has worked with the Contractor, on similar projects in the past. The contractor performed the work in accordance with the contract documents and completed the projects on time.

Rempe-Sharpe and Associates therefore recommends that the Village of Big Rock execute a Contract with Geneva Construction Company of Aurora, Illinois, approving the July 30, 2015 bid, for the BNSF Railroad Grade Crossing Improvements for Quiet Zone Application Project, as immediately amended by Change Order #1. With this Change Order No. 1 reflected, the adjusted project cost is One Hundred Forty Six Thousand, Six Hundred Three Dollars and Sixty Cents (\$146,603.60).

Enclosed, please find three (3) copies of the Notice of Award for the BNSF Railroad Grade Crossing Improvements for Quiet Zone Application Project. Upon the Village's approval, please sign and date all three (3) copies of the Notice of Award. 


