**AN ORDINANCE APPROVING A PROPOSAL FROM O'DONNELL EXCAVATING
AND TRUCKING, INC. FOR SEPTIC TANK PUMPING SERVICES**

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village owns and operates a waste water treatment system which consists, in part, of individual septic tanks located on individual properties, all of which tie into the central waste water treatment system; and

WHEREAS, the waste water treatment system is designed to require the periodic pumping of solids from the individual septic tanks; and

WHEREAS, the Village created a Disposal Zone for the waste water treatment system which, in part, provided an easement over private properties for the purpose of allowing Village access to the system, including the septic tanks, located on private properties for maintenance and repairs; and

WHEREAS, the Village received a proposal from O'Donnell Excavating and Trucking, Inc. to perform periodic septic tank pumping services on behalf of the Village of septic tanks located within the waste water treatment system; and

WHEREAS, the Village of Big Rock Board of Trustees desires to approve this proposal for services, finding O'Donnell Excavating and Trucking, Inc. to be qualified to perform these services, finding its pricing to be the lowest of those companies solicited by the Village, and finding that these services will benefit the public.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The proposal of O'Donnell Excavating and Trucking, Inc. for periodic septic tank pumping services, a copy of which is attached hereto as Exhibit "A", is hereby approved. O'Donnell Excavating and Trucking, Inc. shall perform septic tank pumping services only as directed by the Village.

Section 3: The Village President is authorized and directed to execute this proposal on behalf of the Village of Big Rock.

Section 4: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 5: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.




**AN ORDINANCE APPROVING A PROPOSAL FROM O'DONNELL EXCAVATING
