## ORDINANCE NO. 2015- 21 AN ORDINANCE APPROVING AN AMENDED PTO/HOLIDAY POLICY

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village has previously approved a PTO/Holiday Policy for its full-time and part-time employees; and

WHEREAS, on the advice of Village auditors, the Village of Big Rock Board of Trustees desires to amend its PTO/Holiday Policy to provide that PTO hours/days must be used within the "fiscal year" rather than the "calendar year" since PTO hours/days begin to accrue for employees on the start of the fiscal year.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: The Village of Big Rock PTO/Holiday Policy is hereby amended to provide that PTO hours/days must be used within the "fiscal year" rather than the "calendar year," as set forth in the Policy attached hereto as Exhibit "A." A copy of this Policy, as amended, shall be distributed to all full-time and part-time employees with an explanation of the amendment.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 4: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.

## EXHIBIT "A"

VILLAGE OF BIG ROCK PTO/HOLIDAY POLICY (AS AMENDED)

## Village Of Big Rock PTO/Holiday Policy

PTO & Holiday pay provides you with more flexibility to use your time off to meet personal needs, observe a national holiday, while recognizing your individual responsibility to manage your paid time off.

With the Village of Big Rock PTO program, you will be given a set number of hours based on your status (part time/full time and/or hours worked). Then based on the office demands you will determine how you will use it-for vacation, illness, attendance of children, school activities, medical/dental appointments, personal business or emergencies. A separate holiday schedule will be attached for the days in which the office will be closed in observance.

PTO hours/days must be used within the <u>fiscal year</u> and cannot be carried over to any following years without approval of the Village President.

### **ELIGIBILITY**:

You are eligible to participate in the PTO program if you are a regular status employee scheduled to work at least 20 hours per week.
