

ORDINANCE NO. 2015- 22
AN ORDINANCE ADOPTING A TAX LEVY FOR THE VILLAGE OF BIG ROCK'S
SSA NO. 1 AND SSA NO.2

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, in accordance with statutory obligations, the Village of Big Rock corporate authorities adopted an ordinance establishing Special Service Area No. 1 consisting primarily of the properties within the Facilities Planning Area and the rate and method of apportionment of the assessment for said special service area at their regular meeting on September 14, 2010 in order to generate sufficient revenue to pay for the costs of designing, constructing, operating, and maintaining the community infrastructure improvements for a recirculating sand filtration treatment facility and pressure sewer collection system and the individual property infrastructure improvements for the septic effluent pump (STEP) systems; and

WHEREAS, in accordance with statutory obligations, the Village of Big Rock corporate authorities adopted an ordinance establishing Special Service Area No. 2 consisting primarily of the properties within the Tenerelli Subdivision and the rate and method of apportionment of the assessment for said special service area at their regular meeting on September 27, 2011 in order to generate sufficient revenue to pay for the costs of improving and maintaining ditches, culverts and improvements or the financing related thereto within the Tenerelli Subdivision; and

WHEREAS, the Village of Big Rock Board of Trustees desires to approve an ordinance adopting a tax levy for the Village of Big Rock's SSA No. 1 and SSA No. 2 for Year 2015, with said levy appearing on property tax bills for Year 2016.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.

Section 2: There is hereby levied upon the properties within Special Service Area No. 1 within the Village of Big Rock, County of Kane, State of Illinois the amount as set forth in Exhibit "A" attached hereto.

Section 3: The 2015 Special Service Area No. 1 levy shall be apportioned according to the table attached as Exhibit "A" incorporated herein and made a part hereof.

Section 4: The total amount to be levied for Special Service Area No. 1 is \$107,759.00 and said amount is set forth on the Levy Summary Sheet attached hereto as Exhibit "B."

Section 5: Such levy shall be spent for the objects and purposes as set forth in detail in the Establishing Ordinance and the Rate and Method of Apportionment Ordinance according to the design standards engineered by the Village's consulting engineer, Jim Smith of Applied Technologies and the permit approvals issued by the Illinois Environmental Protection Agency.

Section 6: The Village will levy the Special Taxes on the properties for a maximum period of twenty (20) years, commencing in December, 2010.

Section 7: There is hereby levied upon the properties within Special Service Area No. 2 within the Village of Big Rock, County of Kane, State of Illinois the sum of \$8,000 for the 2015 assessment.

Section 8: The 2015 Special Service Area No. 2 levy shall be apportioned according to the table attached as "Exhibit C" incorporated herein and made a part hereof.

Section 9: The total amount to be levied for Special Service Area No. 2 is \$8,000.00 and said amount is set forth on the Levy Summary Sheet attached hereto as Exhibit "D."

Section 10: Such levy shall be spent for the objects and purposes as set forth in detail in the Establishing Ordinance.

Section 11: The Village President is authorized and directed to execute a Certificate of Tax Levy corresponding to this Tax Levy Ordinance, and the Village Clerk is authorized and directed to file said signed Certificate of Tax Levy with the Kane County Clerk and to revise the exhibits as necessary to submit an accurate and acceptable levy to the Kane County Clerk.

Section 12: All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.

Section 13: This ordinance shall be in full force and effect after its passage, approval, and recording as provided by law.




