AN ORDINANCE EXERCISING THE SECOND OPTION TO RENEW, FOR ONE YEAR, AN INTERGOVERNMENTAL AGREEMENT WITH THE COUNTY OF KANE FOR ANIMAL CONTROL SERVICES

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village of Big Rock previously approved an Intergovernmental Agreement with the County of Kane for Animal Control Services ("Agreement") in Year 2013 for a two-year term, and with two one-year renewal options; and

WHEREAS, the Village approved the first extension of the initial term by ordinance on March 25, 2014, for a one year term commencing on May 1, 2014 and ending on April 30, 2015; and

WHEREAS, the Village of Big Rock Board of Trustees has determined it is in the best interests of the citizens of the Village of Big Rock to renew the Agreement for an additional one year, from May 1, 2015 until April 30, 2016.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

- Section 1: The Village of Big Rock hereby exercises the second one year renewal option for the Agreement, as contained in Section 8 thereof, for the period of May 1, 2015 through April 30, 2016. The Village of Big Rock confirms that it has been and is actively participating in animal control services and facility planning activities that are convened and coordinated by the Metro West Council of Governments, as required by Section 8 of the Agreement, and confirms that it has participated in working towards a long term solution to the regional issues of animal control, as required by Section 9 of the Agreement.
- Section 2: The Village President is authorized and directed to execute this Ordinance and to transmit a copy of this Ordinance to the County of Kane, triggering the extension of the Agreement pursuant to Section 8 of the Agreement.
- <u>Section 3:</u> All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.
- Section 4: This ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
