**AN ORDINANCE APPROVING THE PRELIMINARY BUDGET FOR THE VILLAGE  
OF BIG ROCK FOR THE FISCAL YEAR COMMENCING ON  
MAY 1, 2015 AND ENDING ON APRIL 30, 2016**

**WHEREAS**, the Village of Big Rock has adopted the procedures of the Budget Officer Act (65 ILCS 5/8-2-9.1 et seq.); and

**WHEREAS**, the Budget Officer for the Village has proposed a preliminary budget for fiscal year 2015-16 for the Village of Big Rock and has presented such budget to the Village Board for approval with this Ordinance; and

**WHEREAS**, this Budget Ordinance replaces the annual Appropriation Ordinance for the Village of Big Rock; and

**WHEREAS**, the Village of Big Rock desires to approve this preliminary budget on an emergency basis prior to the start of the fiscal year, and desires to make this preliminary budget available for public inspection and to conduct a public hearing in accordance with the requirements of the Illinois Municipal Code; and

**WHEREAS**, the Village of Big Rock corporate authorities find this preliminary budget to be in the best interest of the Village and will promote the public health, safety and welfare.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Village Board of the Village of Big Rock, Kane County, Illinois, as follows:

**SECTION 1:** The preliminary budget for the Village of Big Rock for the fiscal year commencing on May 1, 2015 and ending on April 30, 2016 is hereby approved in form and substance as set forth in Exhibit “A” attached hereto and made a part hereof.

**SECTION 2:** Once the final budget is approved, the Village Clerk shall promptly file a certified copy of that budget and the corresponding Ordinance with the Kane County Clerk.

**SECTION 3:** Copies of this preliminary budget shall be placed on file for public review in the Village Office located at the Park District Building, 7S405 Madison, Big Rock, Illinois.

**SECTION 4:** All ordinances and parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed to the extent of the conflict.

**SECTION 5:** This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
