DRAINAGE COMMITTEE REPORT

Wastewater Final Completion/Warranty Issues, Sewer Invoice Fee Collection(s)

-John mentioned he has been in communication with a couple attorneys representing the various companies that were involved with the Sanitary Sewer installation. Seems that the Bond Co. is still reviewing the claim and gathering information as well as ATI. On another note however the village will need to start gathering any/all correspondence that occurred between the villages project manager and the companies performing the work at installation. All these materials will be included with the already supplied invoices to assist in validating the villages claim in court.

-Tim prepared a notice that will be mailed out to residents whom have late charges that are still <u>unpaid</u> from past due sewer payments. The late charges are incurred for past due sewer payments and not optional. The notice explains the village will offer a one-time 50% forgiveness of these fees in an effort to collect and get all residents paid up with the village. If the fees are not paid by Feb 1 2017 residents will be considered "unpaid" and their sewer system will be shut-off along with county being notified the property is deemed uninhabitable.

STREET MAINTENANCE REPORT

-The recent street paving project(s) seemed to go well. Builders Paving did a quality job at a fair price for the village. Once spring arrives black dirt and seed will need to be added along the shoulders in the subdivisions due to the drop off that existing from the 2" asphalt overlay.

-Per the boards direction Tim will communicate with Jorge about the villages 2" or more snowfall ordinance. The village requires vehicles to move off the roadway for any snowfall of 2 inches or more for plowing purposes. Jorge will cite vehicles one-time for not moving vehicles off the roadway. After this the village will tow repeat offenders/vehicles . Jorge will need to put a sticker on the vehicle and also a citation on the property to effectively notify the resident of the violation.
