DRAINAGE COMMITTEE REPORT Wastewater Final Completion/Warranty Issues

- -Orenco has completed the work of sealing all the 12" risers the village hired them to do.
- -Darrin serviced about ¼ of all the sewer tanks within the village. He said things looked much better and the infiltration of ground water has been significantly reduced. This also has been reflected on the reports generated by the treatment facility.
- -The village is still working to gather a few remaining documents in preparation for the lawsuit against H. Linden & Sons.

- -Dean will reach out to Jim Bibby when he has an opportunity about the outstanding engineering invoice.
- -Schmitty has been repairing the 3 gravel alleyways in town and the large holes.
- -The Granart Rd. bridge needs some attention very soon. We need to get some pothole patch right away due to this area being in such poor condition.
- -The board understands there are allot of areas within the village that need road repairs. The board is going to try and repave specific sections of roadway every year so it consistently has a plan and residents are made aware of the tentative schedule.
