#### DRAINAGE COMMITTEE REPORT Wastewater Final Completion/Warranty Issues

-The village is still working to fix sewer tank leaks. Although the risers have been sealed underground with a water activated epoxy the village still needs to get all the riser rings ordered and installed. This will then give a tight seal around the riser lids and avoid taking on surface water. Lots of alarms have still been sounding with our last heavy rainfall. Will Shimkus met with an electrician to discuss the leaking electrical box repair(s) that is needed on almost all the tanks. More details to follow...
