AN ORDINANCE APPROVING AN ENGINEERING SERVICES AGREEMENT WITH BRAVO COMPANY ENGINEERING, INC. FOR THE HINCKLEY ROAD PAVEMENT REHABILITATION PROJECT

WHEREAS, the Village of Big Rock is a municipal corporation duly organized and operating pursuant to the laws of the State of Illinois; and

WHEREAS, the Village requires professional engineering services to prepare necessary contract plans and bid documents, to assist the Village with construction observation of the contractor's work, and to perform ancillary tasks thereto, for the Hinckley Road Pavement Rehabilitation Project; and

WHEREAS, the Village has formed a relationship with Bravo Company Engineering, Inc. ("Bravo") and desires to retain Bravo to perform the above-referenced engineering services on behalf of the Village; and

WHEREAS, Bravo has provided an Engineering Services Agreement to the Village for the above-mentioned project, and the Village Board of Trustees desires to approve the same, finding said Engineering Services Agreement is for a needed public improvement project and will serve and protect the public health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Big Rock, Kane County, Illinois, as follows:

- Section 1: The above-stated Recitals are hereby restated and incorporated into this Section 1 as though fully set forth herein.
- Section 2: The Engineering Services Agreement between the Village of Big Rock and Bravo Company Engineering, Inc. for the Hinckley Road Pavement Rehabilitation Project, a copy of which is attached hereto as Exhibit "A," is hereby approved, subject to final attorney modifications which do not alter the essential price or scope of work terms. The Village President is authorized and directed to execute said Engineering Services Agreement once in final form.
- <u>Section 3:</u> All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of the conflict.
- <u>Section 4</u>: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
