### **DRAINAGE COMMITTEE REPORT WASTEWATER FINAL COMPLETION/WARRANTY ISSUES**

-Dean attend the recent drainage committee meeting that had ALLOT of resident participation. Folks are very concerned with the drainage in Bergman. Options were discussed and the village will see what it can do to help. Another resident in the Tenerrelli subdivision is having allot of retention issues on his property. Dean visit all locations. This spring season has been very “trying” for many people with the amount of rain and the typical Big Rock drainage issues.

-Dean stopped at the Dave Hall property. Seems the downspouts are not connected to any gutters resulting in no storm water draining into the village septic tank.

### **STREET MAINTENANCE REPORT GRANART ROAD REHABILITATION PROJECT**

-Dean met with Meyer Paving today and they are starting Hinckley Rd. rehabilitation project this Friday.

-Engineering is still being worked on for the Granart Rd. rehabilitation project. The bid package should be prepared soon.

### **DEPT. OF BUILDING/SAFETY/ZONING REPORT ZIMMERMAN VARIANCE @ 206 E GALENA ZONING ORDINANCE TEXT AMENDMENT RE: TELECOMMUNICATION TOWERS**

-Rich is being very thorough when citing properties for property maintenance violations. Although the village office has received several calls from unhappy residents whom have received citations the board is in agreement that Rich is doing his job correctly.

-On Monday June 3<sup>rd</sup> there was a PZC meeting that included a public hearing for the Ryan Zimmerman variance. Ryan was present to explain his request. The pzc recommendation to the village was to approve the variance request. Total allowable square footage for the two structures would be 1900 for this property.

-John Z. explained details about the proposed text amendment regarding cell phone towers. The village board received an email recently from the village attorney drafting the amendments. John also discussed in detail to the board the changes that were made and reasons they are needed. Dean requested to table the vote this evening in order to give everyone more time to digest.
