PRESIDENT HUMMELL

- -Dean received a call that the DeKane Equipment property was taking on allot of ground water in the septic tank that caused the toilets to back up.
- -Mr. Kaylan on Marie St. called Dean to show him all the water run-off from the street that is washing away his driveway and puddling in his front yard. Dean would like to see the village attempt to help this situation out.
- -There is a resident in the Tenerrelli subdivision that pays into the village SSA that is not benefiting at all. He has significant flooding on his property. It was discussed at the wastewater meeting that possibly a drainage tile could be run a couple hundred feet to the Granart Rd. ditch and assist a handful of properties in this immediate area.

STREET MAINTENANCE REPORT TREE REMOVAL

- -Dean proposes to increase the IGA with the township to offset all the things that Wade helps the village out with. Wade regularly takes initiative to help the village out whenever there is an opportunity.
- -Granart Rd. is open and traffic is running smoothly
- -Big tree on the corner of Raymond and Dugan Rd. that is completely dead and needs to come down. Dean called Pessina Tree Service in Big Rock and obtained a very competitive quote for this work.

- -A PZC meeting is being held next Monday regarding the Rodgers accessory structure variance and the proposed cell towner variance to be located at the fire district property. Dean would like to see the village trustees at this meeting at the fire station at 6:30 pm if possible.
- -Dean and Ted received an email from a Sugar Grove trustee regarding the 47 and I88 interchange. They would like to see a boundary agreement with Big Rock. Sugar Grove would also like Big Rock Township to take back the 200 foot stretch of Camp Dean Road. Does not sound like the village or township is going to negotiate at this time with Sugar Grove about these couple items.

- -Pat mentioned that funds need to be transferred from the general Fifth Third Bank account to the general Resource Bank account to maintain the FDIC insurance for the village monies.
