COUNCIL MEMBER COMMENTS

- -Kelly asked that the jeep on RTE 30 that is for sale could be moved back for line of sight issues. A resident recently phoned the office about this as well. Kathy mentioned she would contact the property owner directly.
- -Ted asked if the proper culvert access permit has yet been filled out by the property owner along Raymond Rd with a new access. Dean will look into this and contact the owner directly.
- -Mark questioned the sale(s) of synthetic marijuana and can it be legally sold at RockWay. John Z. suggested the Kane County Police explore this and make a stop to investigate. The police are more equipped to handle this type of concern and can then supply information to the village. Secondly did the draft letter get sent out to Albiero's. John did confirm it was sent today.

VILLAGE EMPLOYEES

-John shared the information he uncovered in the villages zoning about the use of tent like canopies as a permanent storage. They are not allowed. An email was sent to the village office detailing out what is/is not allowed and regarding the definition of an accessory structure. There is a clause explaining about the village board allowing a specific amount of time for the tent like structures if they deem appropriate.
