## PRESIDENT HUMMELL

- -Dean met with Corky about the recent letter the village sent him and the poor condition of their commercial building. He might have a buyer and asked for some time. The building is dangerous and something needs to be done with it. Dean will continue to keep the conversation open and see what Corky's plan is to remedy the situation. Ideas that were discussed: possibly put a protective fence around the property, give it to the village so they can incur the expense of having it cleaned up, etc...... - -Vacationland is still having issues with Kane County water resources. The storm water management ordinance requires water retention area that will take significant land and that will really not solve the water drainage issues. More details to follow. Dean has been in contact with the owner and will also speak with county again regarding this.

#### COMMITTEE OF THE WHOLE CONSIDERATIONS

#### DRAINAGE COMMITTEE REPORT

-Village needs to budget for a couple items:

Tenerrelli needs a drainage structure on the east side to help alleviate water retention. With a proper repair, water would be routed to flow to the ditch along Granart Rd and then to the creek.

Bergman Estates resident is retaining water that is being shed from all his neighbors and even the roadway. The village needs to aid in this situation and possibly re-slope the street along with create a ditch/water way.

#### STREET MAINTENANCE REPORT

-Bergman Estates significantly deteriorated roadway was discussed. This entire area needs to be re-surfaced. The village will be seeking some engineering for this project and then need to go out for bid for this.
