PUBLIC PARTICIPATION

- -Bob Raymond with the Big Rock Plowing Match Association wanted to inform everyone that August 14th of this year will be the second annual bull riding event. He is asking if the village would again consider another donation for this event. Dean mentioned the board will discuss another sponsorship for this local event.
- -Danyell attended the meeting this evening with an audience to reiterate a couple things. "She started a petition and feels it was taken the wrong way. The only reason there is still conflict is because they feel like they are being attacked for voicing their opinion(s). It's been a controversial issue that has put everyone in a hard position and been blown out of proportion. She is asking the village board to bring everyone back together as a community that has a right to voice concerns. People want to be heard and listen to just as the applicants also should be treated fairly. Additionally she would like to ask with the deletion of the slaughterhouse proposal will this remain permanent/indefinite." The crowd applaud Danyell for voicing these points. Dean "voiced his opinion on how hard the board works and the lack of participation from residents at board meetings. He is very proud how the board operates and the fact the village does NOT tax its residents. Dean also mentioned that the flyers, postcards, and miscellaneous communications on social media had allot of false information in them. The slaughterhouse has been permanently removed from the PUD (planned unit development) however there is NEVER any guarantee that anyone in the future will never present this idea again to the village board!! People

should have come to the board to get their information". John Z. took over conversation about details of the applicant's application to share with the public in attendance to bring everyone up to speed with accurate information. John also elaborated on the definition of a P.U.D and how it offers a bit more flexibility to the applicants. Another resident asked how the people could get information more quickly in an electronic format from the village regarding this topic or anything that impacts residents? John Z. agreed this was a fair question. Dean and John agreed that in the future maybe they can look at ways to get more communication(s) out. Kathy Metzger asked for residents to attend more meetings to get informed. Another resident voiced concerns about the potential mechanic shop usage of the property as well.

-Gary Peterson spoke and thanks the new trustees for joining sometimes a thankless job. He wanted to offer a different perspective on the property. Utilization of the village's comprehensive land use plan (with the latest review in 2014) might help shape what the people and village would like to see happen with Big Rock land. It includes visions for the future and current uses for both the east and west sides of town. He "does not think we should just settle with any applicant and rather should showcase land that could help Big Rock prosper". Maybe we should look at the fact that "we have something to sell". In his opinion these applicants have not had their ducks in row from the beginning and the village should be leery of this. "If you put something good out there it will spawn and if you put something sour out there it will stink".
