#### **COMMITTEE OF THE WHOLE CONSIDERATIONS** DRAINAGE COMMITTEE REPORT

-Dean would like to see the village put some type of ditch/waterway, or pipe along the rear side of commercial buildings at Lincoln & First St. John Z. will draft a temporary easement so the village can perform work in this area if desired and have the residents sign for their approval to do work on the rear of private property.

#### STREET MAINTENANCE REPORT

-Dean discussed with the board what roadways specifically they would like to see resurfaced this upcoming season. The hope is the village can work on getting out bidding sooner rather than later. Also the village needs crack filling throughout as well as some areas (like Rhodes Rd.) will need some patching. Additionally it was also discussed to increase the budget for tree removal this year.

### DEPT. OF BUILDING/SAFETY/ZONING REPORT Discussion/Review of B-3 District Use Provisions

-Discussion took place about consolidating the few "B" zoning districts the village has in order to simplify things. The board also reviewed the current zoning map to visualize current uses and discuss how other municipalities handle their "B" zoning district(s). Specifically talked about was the automotive use (which Big Rock has a high concentration rate of properties with) along Second St.

-Kathy Metzger arrived at 7:25 p.m.

-Alejandro Hernandez is requesting a meeting with Dean to discuss uses on his property on Jericho Rd. He would like to use the property for farming, raising some animals, hosting parties, agriculture, etc...and is looking for village direction. Dean received some direction from the village board and he will convey to Alejandro soon.

-Dean has been in touch with folks looking to purchase the Greyer property. They are interested in doing indoor storage/outdoor storage mainlining on the property. Dean wanted to make sure the board does not for see any big concerns with this. The new owners would in fact be required to do a special use for this proposed use.

#### FINANCIAL REPORT

-Dean is still working to fill the vacancy of village treasurer. He has several applicants that he is scheduling to meet with.
