## **PUBLIC PARTICIPATION**

Mary Houge from Big Rock Library – last year, the Library implemented a loan program for books. The Village made a donation for this program last year, and they are requesting a donation for this year. President Hummell said this request will be on the next Village Board agenda and the Village will look into the amount of the donation last year.

Linda Philippe - Marketing Manager from Girl Scouts Northern Illinois. Girl Scouts is celebrating 75 years in the community on August 13, 2022 at Camp Dean. This will be a community event and she invited all to attend. They will publicize as the date draws nearer. At the event, they want to honor their long-time volunteer, who is a Big Rock resident, by naming one of the cabins after him. The Girl Scouts is soliciting donations for the costs of the naming rights to the cabin and for the related celebration. They will be soliciting donations from area businesses and requested a donation from the Village. The naming rights for the cabin costs \$25,000.00. President Hummell stated that the Village Board would consider this request at a later meeting to be determined.

### **COMMITTEE OF THE WHOLE CONSIDERATIONS**

#### **DRAINAGE COMMITTEE REPORT**

President Hummell stated that work is supposed to start to install a new septic tank on the commercial property owned by Trustee Fitzpatrick, but there currently is too much ground water present to install the tank. Trustee McCannon asked if the tank will be installed at the same location as the existing tank, and President Hummell responded "yes," so that they don't have to install new pipe connections, etc.

#### STREET MAINTENANCE REPORT

Agreements with Crack Attack Concrete for Sidewalk Repairs

Trustee Metzger stated that Crack Attack Concrete is starting the sidewalk repair work on March 28, 2022. President Hummell noted that this is not a sidewalk replacement program, but is repair and maintenance work.

#### DEPT. OF BUILDING/SAFETY/ZONING REPORT

Discussion/Review of B-3 District Use Provisions

President Hummell stated that the Planning and Zoning Commission meeting to discuss the business district use lists is proposed for April 11, 2022. Attorney Zemenak said that meeting date is contingent on Commissioner availability.

President Hummell said that the Township Annual Meeting is Tuesday, April 12 at 7:00 p.m.. He asked about moving the Village Board meeting to 6:00 p.m. on April 12, and the Village Board agreed.

Truck Parking at 6S706 Dauberman Road

Attorney Zemenak noted that the ordinance lists the ancillary materials that can be stored in conjunction with the Intren truck parking. The materials will be stored in Building 8 next to where the trucks park and none of the materials appear to be hazardous. The Village Board had no questions.
