DRAINAGE COMMITTEE REPORT

STREET MAINTENANCE REPORT DEPT. OF BUILDING/SAFETY/ZONING REPORT IGA with Sugar Grove for Administrative Adjudication

- -Property at the corner of Davis & Rte 30 currently owned by Clay Hanninen was discussed this evening. The overgrown residential yard was in serious need of mowing and the village decided to incur the expense of getting this taken care of for now due to this specific location being in the public eye. Tim will try and reach out to the bank(s) and see when they will be handling expenses for the property.
- -The recent bids for roadway resurfacing projects came in well below the engineer's estimate. This is great news for the village. Geneva Construction came in as the lowest bidder and the village will most likely go this route.
- -With recent bids for other resurfacing projects coming in so low the village may have enough funds to resurface Rhodes Rd and its section of Wheeler Rd. this year. More details will be discussed about this.
- -The board decided to "table" the discussion regarding the IGA with Sugar Grove until Matt and John are present.

FINANCIAL REPORT

-Dean discussed the village's financial position with the board and what is currently has available for projects. The board also discussed its budget and future ideas on projects. Thigs have also been progressing well with Dean working with Brian to get him transitioned into the treasurer role.

COMMUNITY REPORT

-Dean will be looking for helping hands in the kitchen at the Plowing Match and annual bull riding event again this year.

COUNCIL MEMBER COMMENTS

- -Kathy asked about the Schollmeyer Landscaping bill for pulverized dirt as this seems a bit excessive.
- -Mark mentioned Crack Attack is on the last phase of sidewalk repair/replacement. He would like to see however the village now consider a sidewalk from Timberview Dr. to Sixth St. so more residents can safely get to the park district.
- -Dean brought up the recent IEPA loan payment fraud the village has recently been victim of. Tim & Dean are in the process of working with the IEPA & authorities to recover these funds and get them into the correct hands.
