#### CALL TO ORDER

**President Matt Fitzpatrick** called the meeting to order at 7:00 PM.

#### PLEDGE OF ALLEGIANCE

**President Fitzpatrick** asked for a moment of silence in honor of our Armed Forces and their Allies.

#### PUBLIC PARTICIPATION

Josh Rodgers, resident, inquired if expanding parking at the Community Park is being considered along with the potential new road connection of MADISON ST to the north to 2<sup>nd</sup> ST. He conveyed that parking is the still the main issue for residents of 6<sup>th</sup> and MADISON, even after expanded parking was added this year. He inquired if the Park District/ HBR Youth Soccer League could schedule the games differently for timing or expand locations to accommodate the very large league. He expressed support of the League and the Community Park, but asked that the Village and Park District consider any short-term measures to alleviate parking congestion also.

**Judy Blincoe**, resident, remarked that she was opposed to the opening of MADISON ST to the north to 2<sup>nd</sup> STREET. She noted that it could create more traffic where children are playing and would compromise the privacy of the dead end. She emphasized that the parking issue is only a problem 6-7 days a year for 4 hours a day, and that building a new road is very costly.

The **Board** discussed details of the parking issues that remain at the **Community Park** as well as possibilities of what can be done in the interim as parking needs only grow with the league every year. The **President** will work with the **Park District** and **HBR Youth Soccer League** to determine any short-term, low-cost solutions.
