Greg Green thanked the Village for installing the new stop signs. He reported the data reflected that after the first week of the stop signs being installed, the traffic count went way down from previous weeks.

President Fitzpatrick got verbal agreement from board to order 3-way and 4-way marker signs to hang below stop signs.

John Rodgerson, Big Rock Historical Society, asked for a \$250 donation for the upcoming annual Big Rock Car Show at Plowman's Park hosted by the Big Rock Historical Society. The theme this year is "orphans and abandoned cars." There will be fast food service, train rides and face painting among other fun activities.

Mary Hague, Big Rock Library, requested a donation for \$250 for the summer reading program and other things. She thanked the village for their work.

Aaron Laho asked about status of a lighting situation the Village is in process investigating. President Fitzpatrick explained that we are currently transitioning companies for our code enforcement service, but that the new Code Inspector is updated of all violations in process and will verify with a lumen reader if the property complies. Mr. Laho also asked if the Village could consider installing radar speed signs on route 30 also. President Fitzpatrick will check with the State rules since it is a state highway. He reported that the Village is in discussion with the Kane County Sherriff to arrange more patrols.

Sandy Madden, Plowing Match Association, asked the Village if they would consider donating \$10,000 for the 2024 Plowing Match Carnival Rides. She thanked the Village for their donation last year. She also informed the Board that the donation is very important, because last year the rides earned over \$10,000 less than the total cost, and if not for the generous donation, there would be no way to host the rides for the kids.
