PRESIDENT FITZPATRICK

President Fitzpatrick relayed that the Sewer Plant Manager has reported a need to replace the sewer check valve on DAVIS ROAD. He recommended that we update the valve so it can be more accessible near the tank instead of the current setup which requires the street to be dug up.

Darrin Boyer has recommended a person to replace him when he retires from the Sewer Plant Manager position. The Board discussed the nuances about whether they should hire him as an employee vs a contracted employee. Discussion about hiring will be made during executive session after adjournment of the Regular Board meeting. The new Sewer Plant Manager will take the reins in December if the Village decides to hire.

DRAINAGE COMMITTEE REPORT

STREET MAINTENANCE REPORT

President Fitzpatrick discussed the details of beginning the HINCKLEY ROAD Bridge Replacement Project. The State grant is approved for 3 phases, and it would take another year or two to begin. The Village will be covering 20%, the state 80% of the costs.

FINANCIAL REPORT

SSA tax levy ordinance

President Fitzpatrick inquired if the Board would still like to consider removing the SSA2 tax levy ordinance. The ordinance is for drainage projects in the Tenerelli subdivision. Ted McCannon pointed out that if we remove the levy, the subdivision would not have money for additional drainage and maintenance. He also pointed out that Tenerelli had specific drainage issues that needed addressing, which was why this subdivision has a levy versus other places in the Village who do not pay a tax levy for drainage projects. Last year, the Village reduced the levy in half. Joe Walsh would like to re-evaluate the necessity of the extra tax levy. Discussion amongst the Board occurred about the duration of the SSA2 tax levy, fund rules and regulations, and the type of drainage projects it has been used for as well as potential future projects. After much discussion, the Board agreed to evaluate the current drainage issues and potential projects in the neighborhood before considering abolishing the SSA2 over the next few weeks. They will re-evaluate whether they should keep it or abolish it at the November 2024 Regular Board Meeting.
